





#### **2020 TREASURER'S REPORT:** Reviewed.

## **APPROVE PROPOSED**

2021 BUDGET: Motion by Denny Birkholm to approve the proposed 2021 budget, 2<sup>nd</sup> by Tim Tabor, carried. Denny Birkholm asked why the insurance was higher than last year. Larry Anderson explained we do not have a bill for the insurance yet, and took into consideration that it could be higher after selling the parsonage.

## **MINISTRY REPORTS:**

Motion by Denny Birkholm to accept ministry reports in packets as written, 2<sup>nd</sup> by John Petersen, carried. Reports not in packet listed below:

- Pastor's report—Larry Anderson, SAM gave a verbal account of his report.
- Property Committee not submitted.
- SMART team—not submitted.
- Call Committee—not submitted.

#### **ELECTION OF SYNOD Assembly Delegates:**

Shawn and Bill Jansen volunteered to attend the remote Synod assembly. Motion by Chuck Moon to have Shawn and Bill

**2021 NOMINATING COMMITTEE: APPOINT** SOMEONE TO FILL COUN-**CIL MEMBER VACANCY:** Denny Birkholm, Judy Petersen and Arla Budd volunteered to be on the nominating committee. Linda Jensen volunteered to fill the current vacancy on the council for the 2021 year. Motion by Chuck Moon to accept Linda on council,  $2^{nd}$  by Carolyn Steele, carried. There was discussion beforehand by Denny Birkholm on changing the terms of council members to one year. Chuck Moon stated that it could be changed to one or two year terms. Bill Steele brought up that they used to have members decide if they wanted to do a one or a two year term and rotate. Chuck Moon also brought up changing the number of council members to between five and seven. These changes would have to be changed in the constitution and voted on by the congregation at another meeting of the congregation.

Bill Steele stated he will come to a council meeting to discuss how to rotate council member terms for one and two years, and how to sign up. Motion by John Peterson to reappoint Marilyn Krogh to the Council, 2<sup>nd</sup> by Larry Anderson, carried.

#### **CALL COMMITTEE UPDATE:** Marilyn Krogh updated members in

Ron's absence that he had drafted a letter that will be going out this week to area congregations to see if there would be any interest in joining together. The letter was sent to Grace, Emmanuel, Oak Lake, Trinity, and Cloverdale Lutheran churches.

#### **CHRIS' FOOD STAND:** Marilyn Krogh volunteered to be the coordinator. Jamie Fogt, Linda Jensen, and Shawn Jansen volunteered to help with the food stand.

## LABOR DAY DINNER:

Denny Birkholm stated they have been discussing getting a pig, and other items that need to be addressed to put on the dinner. It was stated that putting on the dinner depends on the Governor's orders regarding Covid.

## **PARSONAGE UPDATE:**

The parsonage has been sold and discussion was held on where the money should go. Marilyn Krogh brought up that we should look into CDs, creating an endowment fund, repairing or replacing the church roof, and purchasing electronic equipment. Bill Jansen brought up purchasing a high end projector. Shawn Jansen talked about various ministries that some money could go into. Tim Tabor asked if there was someone who could explain to us how creating an endowment fund, etc. would work. Larry Anderson explained that we could contact Thrivent or Rollie Bockbrader of

the NE MN Synod for help with this. Chuck Moon will check into the financial aspect of this. Denny Birkholm stated that the money from the sale of the parsonage should go into a dedicated account and not stay in the General fund. Motion by Denny Birkholm to place the money from the sale of the parsonage into a dedicated account, 2<sup>nd</sup> by Tim Tabor, carried. Denny Birkholm went over the basement air exchange system with us.

#### **UPDATES TO CHURCH CONSTITUTION:** Larry Anderson explained the updates to the constitution and that we also need to create Bylaws. (Copies of the constitution with changes to the language were mailed out to all members before the meeting). Motion by the council to accept the updates to the constitution, 2<sup>nd</sup> by Shawn Jansen, carried.

An announcement was made by Cheryl Kohner that Circle of Faith would be providing cake and coffee on Sunday, March 7<sup>th</sup> after church to say "Goodbye and thank you," to Larry Anderson, who has been with us since September 2020 as our SAM. You will be missed, Larry!

Motion to adjourn the meeting by Bill Jansen, 2<sup>nd</sup> by Joyce Tabor, carried. Meeting adjourned with The Lord's Prayer.
