#### **CHECK-INS, DEVOTION** AND OPENING PRAYER: Devotion provided by Clara.

ACCEPT MINUTES OF **NOVEMBER MEETING:** Motion by Chuck, second by Denny, motion carried.

**TREASURER'S REPORT:** Report was reviewed.

**PASTOR'S REPORT FOR** 

NOVEMBER 2021: Clara provided her report of official activities. She is scheduled to do worship January 9<sup>th</sup> and 23<sup>rd</sup>. January's pulpit supply are not yet scheduled. Bishop has returned the signed SAM contract.

#### **MINISTRY TEAMS:**

• Property—Bill for the steeple repair came in just below the estimate. Will be paid. Quarterly check on the elevator. 2 new batteries installed. Electric boiler has burnt out thermostats. 8 are on order to be replaced. Will also be replacing 2 pressure tanks (1 is failing). Freezing has occurred in the main bathroom. A permanent repair will be explored. The lights in the Sanctuary will all be checked and replaced if needed

before Christmas.

- Family Ministry—No report.
- Music and Worship— Hymns were selected for December. Clara is planning the Christmas Eve Service.
- Circle of Faith—There will be a free community meal on Christmas Day.
